- The annual living allowance for this position is \$22,882 (pre-tax);

- Options for health coverage and childcare coverage are available;
- Pre-Service Orientation during your first week of service is mandatory;
- Your service term ends one calendar year from your start date.

VISTAs are required to give 100% of their efforts to their projects and to community benefit. Sometimes work over weekends and non-standard work hours are required.
